




## Editor's Note

# KITALE NATIONAL POLYTECHNIC ON TRACK TO EXPAND ACADEMIC OFFERINGS WITH ACCREDITATION AS A QUALIFICATION AWARDING INSTITUTION

In a groundbreaking development, Kitale National Polytechnic was officially accredited as a Qualification Awarding Institution (QAI), marking a significant milestone in its academic journey. The accreditation granted Kitale NP the authority to develop and provide its own curricula, ultimately leading to the award of qualifications.

Following the accreditation, Kitale NP submitted a total of 24 curricula for registration as national qualifications. However, only 5 of them met the stringent requirements and standards set by the Kenyan National Qualifications Framework (KNQF). This selective approval underscored the commitment to maintaining high-quality educational standards.

The recent visit to Kitale NP by the KNQA team focused on enhancing the institution's understanding of the registration requirements for the remaining 19 curricula that did not initially meet the KNQF standards. This collaborative effort aims to ensure that all offerings from Kitale NP meet the national qualifications criteria.

Undeterred by the initial evaluation results, Kitale NP has resubmitted the necessary requirements for the 19 curricula that are yet to be registered on the KNQF. The commitment to meeting and exceeding national standards reflects Kitale NP's dedication to providing top-notch education. Currently, a team from the Authority is diligently evaluating the resubmitted curricula. Their thorough assessment will play a pivotal role in determining the approval and subsequent registration of these qualifications onto the KNQF.

## KNQA SPEARHEADS KENYA REVIEW OF KCATS POLICY TO BOOST EDUCATION AND CAREER MOBILITY

In a bid to revolutionize education, training, and career paths, the Kenya Credit Accumulation and Transfer System (KCATS) policy is currently under review. According to the Kenya National Qualifications Authority (KNQA) Chairperson,

Stanley Kiptis, the policy aims to facilitate access, mobility, and seamless progression within various educational and career trajectories. Mr. Kiptis emphasized that the KCATS policy will play a pivotal role in enhancing transparency, efficiency, recognition, and the overall quality of education and training in Kenya. Speaking during the inauguration of a 19-member team in Naivasha, he highlighted the critical role the policy will play as an instrument guiding learner progression.

"The Qualifications landscape in Kenya encompasses multiple stakeholders who must work together to ensure relevance, portability of qualifications, mobility of labor, and global competitiveness of our qualifications," Mr. Kiptis stated.

The policy review aligns with the recommendations of the Presidential Working Party on Education Reforms, specifically addressing the need to support progression and mobility of Technical and Vocational Education and Training (TVET) graduates through credit transfer.

The KNQA, mandated by the KNQF Act No. 22 of 2014, is tasked with developing policies and standards to guide the national qualifications system. This aims to enhance the skills development process, transferability of skills, clarify progression pathways, and enable lifelong learning. Dr. Alice Kande, the Acting Director General of KNQA, expressed optimism about the committee's role in providing a national credit transfer system policy to avoid wastage of knowledge. She emphasized the importance of conducting a national and global situational analysis, considering the advanced stage of implementing the Africa Continental Qualifications Framework (ACQF). Dr. Kande elaborated on the ACQF, designed as a referencing qualifications framework for the African continent, enhancing transparency, comparability, and the quality of qualifications. The framework aims to promote mobility for further studies and work across African countries. The 19-member team appointed by the Cabinet Secretary comprises experts from various institutions, including KNQA, Directorate of Quality Assurance, Technical and Vocational Education and Training Authority (TVETA), universities, National Industrial Training Authority (NITA), and other relevant bodies. The team's collaboration is expected to pave the way for a comprehensive and effective KCATS policy that aligns with global educational standards and promotes a seamless learning experience for Kenyan students.

# KNQA'S INTERNAL AND TARGET STAKEHOLDERS' VALIDATION OF THE KENYA NATIONAL QUALIFICATIONS CLASSIFICATION STANDARD (KNQCS)



Education and training providers in Kenya use a variety of nomenclatures and codes to identify qualifications, creating a situation where multiple qualifications awarding bodies each employ their own distinct approaches for identification and classification. Kenya National Qualifications Framework (KNQF) Act No 22 of 2014, Section 8 (1) (f), empowers the Kenya National Qualifications Authority (KNQA) to create and disseminate codes and guidelines pertaining to National Qualifications. In Education and training providers in Kenya use a variety of nomenclatures and codes to identify qualifications, creating a situation where multiple qualifications awarding bodies each employ their own distinct approaches for identification and classification. Kenya National Qualifications Framework (KNQF) Act No 22 of 2014, Section 8 (1) (f), empowers the Kenya National Qualifications Authority (KNQA) to create and disseminate codes and guidelines pertaining to National Qualifications. In response to this directive, KNQA led by (SAQA) Department convened an internal and targeted stakeholders' workshop to validate the Kenya National Qualifications Classification Standard (KNQCS) draft. This intends to establish a standardized system for coding national qualifications awarded within the country. Involvement of key stakeholders tasked with regulating, developing curriculum, assessing, and awarding qualifications in the validation process guarantees that the KNQCS aligns harmoniously with regulatory norms, industry requirements, national educational directives, and global benchmarks.



Their specialized knowledge ensures that the classification meets industry requirements, bolsters quality assurance measures, and cultivates transparency and consensus. This collaboration nurtures trust and acceptance within the educational sphere, streamlines alignment with international standards, and ultimately results in a robust, universally embraced classification

standard that offers advantages to educational institutions and society at large. KNQCS aligns with ISCED, utilizing it to categorize and code programs and qualifications using three primary cross-classification variables: fields of education and training (ISCED-F 2013), KNQF levels, and levels of educational completion (ISCED-P 2011). The Authority is further aligning KNQCS to Kenya Standard Classification of Occupations (KeSCO) 2022 which gives an insight into the occupational framework: type of work performed in jobs found in establishments, industry or a country; nature of tasks performed; body of knowledge, skills and skill level required for a job holder to effectively perform those tasks. KeSCO 2022 describes and assigns unique codes to all occupations, in order to classify them as they are found within the Kenya labour market and in a comparable level globally. The implementation of the (KNQCS) holds significant promise for the educational landscape. By aligning qualifications with the demands of the labor market, it empowers employers to better understand the knowledge, skills, and competencies associated with different qualifications. This in turn, facilitates a more transparent and efficient hiring process, bridging the gap between education and industry needs.

## MACHOGU LAUDS KNQA AS THE AUTHORITY INAGURATES ITS NEW COUNCIL MEMBERS

Education Cabinet Secretary Ezekiel Machogu commended the Kenya National Qualifications Authority (KNQA) for the progress it has made to date in ensuring that Kenya has full proofed qualifications that are relevant, globally competitive, portable and allow for mobility of labour and skills across the globe.

"Today is not just as any other day, but an opportune moment to commit to the cause of effectively implementing the Kenya National Qualifications
Framework," said Mr Machogu.

On her part, Dr Muoria. disclosed that the government was on course with implementation of key reforms in the education and training sector in the endeavor to enhance relevance, equity, and access to education, and ultimately lead to decent employment and decent living.

"The ongoing implementation of CBC and CBET, imply that KNQA should walk ahead of the pack in ensuring that all qualifications are properly mapped in the Kenya National Qualifications Framework.

This will not be a mean fit, members of KNQA Council. Much work awaits us to transition in a most effective manner. The role of the Kenya National Qualifications Authority in promoting visibility of qualifications, skills and competencies cannot therefore be overstated," said the Principal Secretary.

She went on: "We are also operating at a time when the concept of National Qualifications Framework has gained traction internationally. I would like to commend KNQA for putting Kenya in the global map as far as implementation of the KNQF is concerned. I was glad to attend the 1st Continental workshop that

brought together delegates from 34 countries across Africa; that was a show of confidence that indeed as a continent we are keen to promote transparency of qualifications and mutual trust between qualifications frameworks for lifelong learning in Africa."

She called on the new Council members who will serve for a period of three years effective October, 19, 2023 to seize such opportunities and make National Qualifications Operational in a changing world.

Mr . Kiptis , Ag. Director General Dr Alice Kande and senior management attended the meeting. KNQA Chairperson Mr Stanely Kiptis assured the PS that the Authority is up to task in development of all required national policies to enable implementation of the qualification framework. Dr Kande, applauded the government for the support that she has given the Authority in implementing its mandate.

"We are grateful and now with a new Council, we will ensure that we develop all required policies that we had plans for," said Dr Kande adding that the Authority has already issued guidelines on how skilled workers without a formal education will be certified under a programme dubbed recognition of prior learning.

Dr Kande also noted that the Council brings in a mix of rich expertise which will go a long way in ensuring effective implementation of the KNQF.

"We are keen to ensure that qualifications obtained in Kenya are relevant, credible, portable, and globally competitive," said Dr Kande.
